

RESOLUTION 2023-002

VILLAGE OF BEULAH

ESTABLISHING CURRENT WATER & SEWER RATES AND CHARGES

WHEREAS, the Village of Beulah operates public water and sewer systems on a public utility rate basis: and

WHEREAS, Village Water Ordinances 2017-1, 2017-2 and Village Sewer Ordinance 2021-1 empower the Village Council to establish appropriate rates and charges that provide for the retirement of bond indebtedness for the system, for the operation and maintenance of the system and the construction of replacement facilities: and

WHEREAS, the Village Council is authorized under the Village Water Ordinances 2017-1 and 2017-2 and Village Sewer Ordinance 2021-1 to establish rates and charges by resolution of the Village Council; and

WHEREAS, the Village Council has reviewed the water and sewer funds and the needs of the systems to determine the rates and charges necessary to provide for sufficient amounts for the payment of the systems' expenses; and

WHEREAS, the Village Council has determined that an increase in certain rates charged is necessary for the payment of the systems' expenses;

NOW THEREFORE, the Village Council resolves that the following rates and charges shall be established as follows, effective July 1, 2023:

Quarterly water service charge	\$ 116.53
Quarterly water service charge outside village	\$ 128.19
Water usage charge per 1,000 gal.	\$ 11.11
Water usage charge per 1,000 gal. outside village	\$ 12.23
Quarterly sewer operation charge	\$ 52.37
Quarterly sewer debt service charge	\$ 15.63
Total quarterly sewer service charge	\$ 68.00
Quarterly sewer service charge outside village	\$ 73.00
Sewer usage per 1,000 gal of water used excluding separately metered irrigation	\$ 6.00
Sewer usage per 1,000 gal of water used, outside village	\$ 7.00
Water Hook-Up (Tap/Benefit Charge) includes meter by village	\$ 3,500.00
Sewer Hook-Up (Tap/Benefit Charge)	\$ 3,500.00
Turn off/on seasonal charge	\$ 35.00
Turn off/on turn on one additional meter in same trip	\$ 12.00
Delinquent shut off/on fee	\$ 110.00

- Benefit charge (hook-up fee) is for the privilege of connecting and receiving service only.
- Property owner is responsible for installation of, cleaning and repair of sewer lines and water service from residence and/or business to tap in location of sewer and/or water mains. Any work done on water or sewer lines, where they are tapped into the mains, must be supervised and inspected by the Village Maintenance Superintendent. Proper materials, fittings etc. must be used.
- Frozen services will be thawed from the main line to the meter. **Water line must be conducive to electric thawing.**
- Each lot in the The Woods at Crystal Lake (Benzonia Trailer Park) is considered a single-family dwelling (ready to serve).


