President Jeri VanDePerre stated that the State Revolving Fund doesn't allow building for the future – only for what is here and now.

President VanDePerre stated that due to the violations, the State of Michigan won't continue with us attached.

Trustee Hook stated that when we are operating properly, Area 31 would send their sewer and would pay for expansion.

Dale Rineer asked how many sewage permits each year; it has always been a mandate.

Margaret Lumm, 6691 Crystal Ave, is concerned that there was not a lot of information at the presentation; could we have another public meeting.

President VanDePerre reiterated that this meeting is for funding, we want our name in the State Revolving Fund.

Trustee Loll stated that this is a big deal, we need to be transparent; we should have another meeting with a mass mailing to make sure the public knows.

Trustee Heniser stated that we have a meeting every month, the same day each month.

Michelle Thompson, 369 Court Place, she understands funding, you need to figure this out and let us have a sewer system we can trust.

Trustee Downs stated that we have an opening, we need you, think about the election.

Tim Quick stated that he owns a business, but doesn't live here.
