Topic: Policy for Village Displays of Flags and Banners

President VanDePerre read her post to Overheard in Benzie as to why she removed the Flags. She takes full responsibility to honor First Responders.

Turned over to Kerrie Zeits, Village Attorney  
She stated that this created a constitutional issue:

1. Traditional Public Forum – where the status is the street corner, the sidewalks and public parks where the public traditionally go.
2. Designated public forum – forum that is not a traditional forum, the government has generally made them available to the public for full expression – i.e. public comment at a meeting.
3. Non-Public Forum – is a forum but not generally available to the public and the access is given by the government on a selected based on the compatibility of the speech with the forum's purpose.

What forum is created with flags or no forum at all. All three types of forums were discussed by council. Pros and Cons of each.

Need to be clear about if they want public forum or non-public. This is to avoid violation in the future. You could list specific flags for special events and state other flags for Village events as approved by council.

Sheriff Rosa explained the meaning of the Black/Blue and Black/Red Flags.

Candi Riddell, Crystal Moon, spoke about hometown officers in Missouri shot giving a ticket to someone who then shot both officers – upset about the flags coming down and her & Kelly are the only business owners who show up for this meeting.

Amy Nowicki, 9446 W Sleepy Valley Dr, Empire, cautions the board about reacting to three complaints; stated her customers (Lucky Dog) come here to get away from things.
